**Rates, Terms and Conditions  
for Fixed Departures (FD)**

*Mountain Lodges of Peru invites you on a cultural exploration of the Urubamba Valley, the celebrated “Sacred Valley of the Incas,” and the spectacular archeological site of Machu Picchu, combined with activities in the less visited and uncrowded Lares region north of Cusco, noted for its rural atmosphere, traditional weavers attired in colorful dress, and roving herds of alpacas and llamas—an authentic slice of Peruvian life.*

## Rates

- / Cusco to Cusco itinerary. MLP services end upon arrival in Cusco on Day 5 or 7.
- / Guaranteed departures with a minimum of two (2) guests.
- / Services as described in the MLP Fixed Departure brochure.

### 5-DAY PROGRAM

March 1 - 31 & November 1 - December 14	US\$ 2,100 per person based on shared accommodations.
April 1 – October 31 & December 15 - 31	US\$ 2,800 per person based on shared accommodations.

### 7-DAY PROGRAM

March 1 - 31 & November 1 - December 14	US\$ 2,600 per person based on shared accommodations.
April 1 – October 31 & December 15 - 31	US\$ 3,600 per person based on shared accommodations.

- / MLP currently operates these programs between March and December.
- / Rates per person in US dollars.

### WHAT IS INCLUDED?

- / All transportation services for the duration of the standard detailed itineraries.
- / 4 or 6 nights (according to each respective program) of accommodations in MLP lodges and affiliate hotels.
- / Daily “a-la-carte” activities; guests choose from a daily list of active and cultural options.
- / Entrance fees to archaeological sites and other points of interest.
- / Guided visit of Machu Picchu Sanctuary (entrance, transportation to and from the site).
- / All meals and beverages including soft drinks and a house selection of beer, wine, and spirits including pisco\*.
- / Fully-guided bilingual activities and excursions, except for scheduled times marked *at leisure*.
- / All gratuities for the staff at all MLP lodges and in the field.\* Gratuities for the guides are not included and are at your discretion. In general, we suggest \$10- \$20/day (per person) for lead guides and \$5 - \$15/day (per person) for assistant guides. **Note:** *Gratuities for the staff at our affiliate hotels are not included.*
- / Wireless internet access (Wi-Fi) at all lodges.

*\*All meals and beverages at MLP lodges. We also offer a premium selection of wines, spirits and liquors at an additional cost. Soft drinks and alcoholic beverages are subject to an additional cost at our partner properties in the Sacred Valley and Aguas Calientes. In consideration of the adventurous nature of the MLP experience, the risks associated with alcohol consumption, and the importance of maintaining positive group dynamics, we encourage guests to enjoy alcoholic beverages in moderation. In accordance with company policy, MLP guides and/or other company/lodge representatives may modify or suspend a guest's access to alcohol and/or trip partially or entirely if the guest's health or safety may be at risk due to excessive alcohol consumption.*

## NOT INCLUDED

- / Massage service.
- / Permits for Huayna Picchu Mountain and/or Machu Picchu Mountain.
- / Bottled water and sports drinks. As per our ongoing effort to reduce plastic waste on the trail and at the lodges, we do encourage guests to use the refillable water bottle that is provided to each guest at the pre-trip briefing. The highest-quality filtered water is available at all of MLP lodges.
- / Local taxes (18% IGV) on meals and lodging applicable to Peruvians, foreign residents, and tourists traveling in Peru for 60+ days.

## Terms and Conditions

---

### SINGLE OCCUPANCY REQUEST

- / Requested Single Room: subject to a 50% supplement in addition to the standard retail cost/per person.
- / Single traveler willing to share: no additional charge\*

*\*Note: In the event that a traveler is willing to share a room, MLP will assign a guest roommate prior your trip. If you have any preference, please let your Travel Specialist know.*

### CHILDREN

Due to the high altitude in the Cusco region and the physically demanding (soft-adventure) nature of some activity options, we **highly recommend** an age restriction of 10+ for children who will participate in the hikes, and an age restriction of 8+ for children who will participate in the cultural activities only. For families wishing to travel with younger children, we suggest hiring an additional private guide and/or vehicle to ensure an appropriate family experience (subject to additional cost). Please ask your travel specialist for more information.

#### Please note

- / Children under 12 years-old, when sharing a room with parents or guardians, will be granted a 50% discount off of the standard rate of the 5- or 7-day programs (maximum two children per room).
- / Children from 13 to 16 years-old, when sharing a room with parents or guardians, will be granted a 25% discount off of the standard rate of the 5- or 7-day programs (maximum two children per room).
- / If the child is sharing with only one parent or guardian, both guests are subject to the standard rate.
- / When one parent or guardian is sharing a room with two children, the discount will apply to only one child; the standard rate will apply for second child.
- / Discounts do not apply to single room requests for children. In this case, the child guest will be charged the standard rate plus the single supplement surcharge.

### PRIVATE GUIDES

Depending on group size, MLP schedules two or more guides for the duration of the itinerary. Private English-speaking guides can be arranged at an additional cost (per guide) for the standard itinerary (regardless of the number of guests). The private guide would join the group on Day 1 and also be present at the pre-trip briefing. Please inquire for guidance in other languages.

### PERMITS TO HUAYNA PICCHU AND MACHU PICCHU MOUNTAINS

Guests have the option to add a hike to Huayna Picchu Mountain or to Machu Picchu Mountain, permits are subject to availability and to an additional cost. Please consult with your MLP Travel Specialist for detailed information and rates.

### ADDITIONAL DAY AT MACHU PICCHU

Although guests will have enough time to see the main parts of Machu Picchu during the regular guided tour, some may want to expand their exploration to include climbing Machu Picchu Mountain and hiking to the Sun Gate, Inca Bridge, and more. Please ask your MLP Travel Specialist for detailed information and extension rates.

## DUFFLE BAG LOANS

MLP offers duffle bags for the duration of the trip. These must be returned to your guide on the last day of your trip. In case these are not returned, there will be a charge of \$50 for each duffle bag. Please ask your MLP Travel Specialist if you wish to use a duffle bag during your trip.

## RESERVATIONS & PAYMENT

- / At time of reservations, MLP will need the following information: **departure date, full name, passport number, nationality and date of birth of all participants.**
- / Reservations will be held for 48 hours; if a deposit is not made during this window, then the reservation will be cancelled automatically. However, your MLP travel specialist will make an attempt to contact you before this happens.
- / Complete guest information is required 90 days prior to departure date.
- / Any additional charge made in MLP lodges must be paid with a credit or debit card. No cash is allowed for a minimal non-contact policy.

## DEPOSIT AND FINAL PAYMENT

- / A non-refundable deposit of \$ 500.00 USD per person is required at time of booking.
- / The balance payment is due 60 days prior to the departure date.

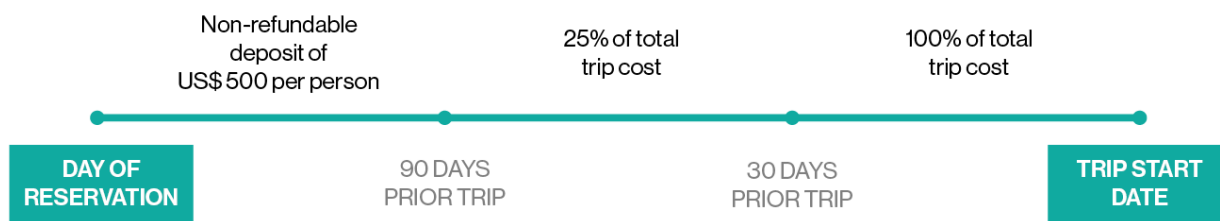
**Note:** Third-party travel services purchased through MLP may have different payment, cancellation and transfer policies. Please ask your Travel Specialist for specific details on this.

## CANCELLATIONS

In the event of travelers' cancellation, MLP requires notification in writing, by email or instant message.

The following cancellation fees apply:

- / Up to 90 days prior to trip start date: We keep your non-refundable deposit of US\$500 per person.
- / 89 - 30 days prior to trip start date: 50% of the total trip cost.
- / 29 - 0 days prior to trip start date: 100% of the total trip cost.



## TRANSFER FEE — CHANGING TRIP DATES OR TRAVELERS' NAMES

- / Up to 90 days prior to departure date: No charge for date or name changes.
- / 89 to 30 days prior to trip start date: An additional 15% of the total trip cost.
- / 29 to 0 days prior to departure date: An additional 50% of the total trip cost.



**Note:** If date transfers are requested for a time beyond 18 months, an additional for rate update may be applicable.

### ADDITIONAL NOTES ON TRANSFERS

- / It is not necessary to specify a future departure date upon requesting a transfer.
- / Any planning fees paid in 2023 will be completely transferrable to future bookings within 12 months of the initial date of departure. If you are not sure if you will travel within a year, we will send you a credit voucher that can be used against any MLP trip in the next two years - This credit is transferable and cannot be exchanged for cash.
- / Prices of the trips and other services are subject to change due to seasonality.

### TRAVEL INSURANCE

The Sacred Valley and Lares Adventure is a multi-activity program in remote locations and thus, comes with inherent risks. In order to provide a safe experience for everyone, we kindly request that each guest present valid proof of medical insurance. Please take care when assessing and/or purchasing your insurance policy to ensure that it includes, at minimum, coverage for emergency medical treatment and evacuation during adventure travel activities.

The following information is REQUIRED at least 60 days prior to trip start date:

- / Name of insurance company and name of specific policy (if applicable).
- / Coverage registration number or code.
- / 24hr emergency telephone numbers provided by the insurance company.

A full payment must be made in order to book and confirm the following services: Hiram Bingham train, additional Machu Picchu entrance, additional Huayna Picchu permit, cruises, flights and some hotels like Belmond Sanctuary Lodge, Skylodge and Titilaka Hotel. Your Travel Specialist will advise of specific reservations and cancellation terms.
